WISE COUNTY PUBLIC SERVICE AUTHORITY GLAMORGAN COMMUNITY SEWER COLLECTION PROJECT

Separate sealed Bids for the construction of the “**Glamorgan Community Sewer Collection Project**” will be received by Cody A. McElroy, P.E., Executive Director of Wise County Public Service Authority, 5622 Industrial Park Road, Norton, Virginia 24273 until **2:00 p.m.** local time on **Thursday, February 16, 2023**, at which time the Bids received will be **publicly opened and read aloud**.

This Project includes construction of approximately 8,762 L.F. of 8-inch sewer line, 230 L.F. of 6-inch sewer line, 4,034 L.F. of 4-inch sewer line, 67 manholes, connection of 51 services, 330 L.F. of 16-inch steel casing, and associated appurtenances.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis. The Project is funded through the **Virginia Department of Housing and Community Development, Appalachian Regional Commission, LENOWISCO Planning District Commission, and the Virginia Department of Environmental Quality**.

Bidders must comply with the following: the President’s Executive Order # 11246 prohibiting discrimination in employment regarding race, color, creed, sex, or national origin; the President’s Executive Orders # 12138 and 11625 regarding utilization of MBE/WBE firms; the Civil Rights Act of 1964, the Davis-Bacon Act; and Section 436 of P.L. 113-76 American Iron and Steel. Bidders must certify that they do not or will not maintain or provide for their employees any facilities that are segregated on the basis of race, color, creed, or national origin.
