**BEAVER CREEK SEWAGE FLOW EQUALIZATION BASIN PROJECT  
BVU AUTHORITY**

Separate sealed bids for construction of the Beaver Creek Sewage Flow Equalization Basin Project - Contract 1 and Contract 2 will be received by the BVU Authority located at 15022 Lee Highway, Bristol, Virginia at **2:00 p.m.** on **June 8, 2023** and then at said location publicly opened and read aloud.

Contract 1 - Flow Equalization System involves construction of a 2.0 Million Gallon prestressed concrete storage tank, pump station, and related improvements.

Contract 2 - Interceptor Replacement involves approximately 2,200 LF of 42" and smaller gravity sewer line, manholes, and related improvements. The Project is funded through the Virginia Department of Environmental Quality.

Printed copies of the Bidding Documents may be obtained from the Issuing Office, during the hours indicated above, upon payment of \$200, (non-refundable) for each set. Contractors have the option to purchase an electronic set of bidding documents (Adobe PDF Format) for a \$50.00 non-refundable fee. Checks for Bidding Documents shall be payable to The Lane Group, Inc. Upon request and receipt of the document deposit indicated above, the Issuing Office will transmit the Bidding Documents via delivery service. The date that the Bidding Documents are transmitted by the Issuing Office will be considered the Bidder's date of receipt of the Bidding Documents. Partial sets of Bidding Documents will not be available from the Issuing Office. Neither the Owner nor the Engineer will be responsible for full or partial sets of Bidding Documents, including Addenda if any, obtained from sources other than the Issuing Office.

The procedure for withdrawal of bids shall be according to provision B.1 contained in Va. Code § 2.2-4330 as amended.

If a contract is for one hundred twenty thousand dollars (\$120,000) or more, or if the total value of all construction, removal, repair, or improvements undertaken by the bidder within any twelve-month period is seven hundred fifty thousand dollars (\$750,000) or more, the bidder is required under Title 54, Chapter 11, Code of Virginia (1950) as amended, to show evidence of being licensed as a "Class A Contractor." If a contract is seven thousand five hundred dollars (\$7,500) or more, but less than one hundred twenty thousand dollars (\$120,000), the bidder is required to show evidence of being licensed as a "Class B Contractor." The bidder shall place on the outside of the envelope containing the bid and shall place in the bid over his signature whichever of the following notations is appropriate:

"Licensed Class A Virginia Contractor No. \_\_\_\_\_"

"Licensed Class B Virginia Contractor No. \_\_\_\_\_"

The BVU Authority is an Equal Opportunity Employer and will not discriminate on the basis of race, creed, color, sex, national origin, age, handicap or familiar status. MBE/WBE firms are encouraged to submit bids. Bidders must comply with the following: the President's Executive Order # 11246 prohibiting discrimination in employment

regarding race, color, creed, sex, or national origin; the President's Executive Orders # 12138 and 11625 regarding utilization of MBE/WBE firms; the President's Executive Order 13658 regarding minimum wages on federal funded construction contracts, the Civil Rights Act of 1964, the Davis-Bacon Act and Section 436 of P. L. 113-76, American Iron and Steel. Bidders must certify that they do not or will not maintain or provide for their employees any facilities that are segregated on the basis of race, color, creed, or national origin.

An optional Pre-Bid Conference is scheduled to be held at **10:00 a.m.** local time on **May 18, 2023** at the BVU Authority, 15022 Lee Highway, Bristol, Virginia 24202. Attendance is not mandatory, but all BIDDERS are encouraged to attend.
