INTERSTATES WATER AND SEWER DISTRICT
WATER SYSTEM TRANSFER PROJECT

Sealed bids for construction of the **Interstates Water and Sewer District Water System Transfer Project** will be received by The Town of Dobson at 307 North Main Street, Dobson, North Carolina until **2:00 p.m.** local time on **January 20, 2026**, and then at said location publicly opened and read aloud.

Construction includes:

- a. Installation of an 8" main line master meter and electric control valve assembly at the Route 89/Maple Grove Church Road intersection.
- b. Installation of a 6" main line master meter and electric control valve assembly on Oak Grove Church Road.
- c. Replacement of approximately 74 existing water service meters.

The Town of Dobson reserves the right to reject any or all proposals. Any bid received after the designated bid closing time will be rejected and will not be opened.

NOTE: Prospective bidders are hereby notified that they must have proper license under the state laws governing their trade. General contractors are notified that Chapter 87, Article 1, General Statutes of North Carolina will be observed in receiving and awarding this contract.

All Bidders are required to submit a 5% Bid Security with their bid. Upon award of contract, a separate performance bond and payment bond each in the amount equal to one hundred percent (100%) of the Contract price will be required. Carriers must be authorized to do business in North Carolina.

The Town reserves the right to reject any bid for failure to comply with all bidding requirements or of any of the Contract Documents; however, it may waive any minor defects or informalities at its discretion. The Town further reserves the right to reject any and all proposals or to award the Contract which in its judgment is in the best interest of the Town of Dobson.
