FEATURED PROJECT

SPENCER'S MILL SITE REDEVELOPMENT PROJECT -
CITY OF MOUNT AIRY, NORTH CAROLINA

TLG is providing design and construction phase services to the City of Mount Airy in its efforts to redevelop a former textile mill property. The overall project involves the City partnering with private developers to renovate and convert the mill buildings for new end uses.

Phase I of the site redevelopment includes relocation and replacement of approximately 1,600 LF of 48 inch and smaller storm drains, 1,600 LF of 12 inch and smaller sanitary sewer, 700 LF of 12 inch and smaller water lines, street and parking lot reconstruction, and related improvements in support of a private project to convert a former mill building into apartments. The Phase I Site Redevelopment Project cost is approximately \$2.0 million.

Construction of the Phase I project is expected to be near completion by the end of 2019.
